This agreement by and between All Roadside Towing and _____ shall serve as authorization to service the property located at _____

All Roadside Towing will provide services to ensure residents and/or businesses access to their assigned spaces and/or garages. Furthermore, All Roadside will conform with the San Diego County Fire Departments demands regarding public safety and emergency vehicle access.

All Roadside Towing agrees to respond to the property within a reasonable period when summoned by management or an authorized agent for the purpose of removing any vehicles that are not in compliance with the property or business regulations.

All Roadside Towing agrees to conduct random on-site inspections of the fire lane/ red zone areas and for vehicles parked in a manner that restricts ingress or egress to the property.

As prescribed by law, All Roadside Towing will promptly report all impounded vehicles, to the appropriate law enforcement agency. All Roadside Towing guarantees this will happen in 60 minutes or less. Furthermore, All Roadside will perform all operations within the guidelines set forth in Section 22658 and Section 22658.1 of the California Vehicle Code.

All Roadside Towing agrees that their employees will act and conduct themselves in a professional manner on and off the above property address. Their employees will be courteous, respectful, sympathetic, and kind to all residents, staff, contractors, and everyone associated with the above property.

All Roadside Towing will remove any unauthorized or abandoned vehicle at no expense to the property owner or agent. All vehicles removed from the property, will be towed at



the vehicle owner’s expense. All Roadside Towing agrees to furnish legal signage and paint fire lanes if needed upon agreement of service.

This agreement is effective upon signature and may be canceled by either party notifying the other in writing. Service shall immediately cease upon receipt of a written cancellation request by either party.

All Roadside Towing is responsible and liable for any damages to vehicles resulting or arising from All Roadside’s actions or omissions in conducting tows from your property. Resolution of any dispute in this regard shall be a matter entirely between All Roadside and the vehicle owner(s). All Roadside agrees to indemnify and hold the Property Owner/Agent harmless related to any (1) Code violations or (2) property damages which allegedly have arisen from All Roadside’s actions or omissions during the impound process.

By Signing my signature below, I certify as an owner / agent that I authorize All Roadside Towing to a general towing authorization of the fire lanes, fire hydrants, stenciled red zones, for vehicles parked in a manner that restricts property access, and for vehicles in violation of parking regulations at the above-mentioned address.
